# Do You OWE CHILD SUPPORT?

---

Section 51.70 (a) (8) of Title 22 of the Code of Federal Regulations states, in part, that if you are certified to Passport Services by the U.S. Department of Health and Human Services (HHS) to be *in arrears of child support payments in excess of \$2,500, you are ineligible to receive a U.S. passport.* If this applies to you, Passport Services strongly recommends that you contact the appropriate State child support enforcement agency to make payment arrangements before applying for a passport. After payment arrangements have been made with the State agency, the following steps must be completed in order for you to be eligible to receive a U.S. passport:

- ▶ The State child support enforcement agency must certify to the U.S. Department of Health and Human Services (HHS) that acceptable payment arrangements have been made; AND
- ▶ HHS must notify Passport Services by the removal of the name from the electronic list HHS gives to Passport Services. **Passport Services has no authority to issue a passport until HHS removes your name from its list.**

Please note that it can take **2-3 weeks** from the time you make payment arrangements with the State child support enforcement agency until your name is removed from HHS' electronic list. Some States require that back child support is paid-in-full before your name is removed.
