***APPLICANTS FOR LODGING TAX ADVISORY COMMITTEE (1 YEAR TERMS)**

The Lodging Tax Advisory Committee performs the functions and duties described in RCW 67.28.1817 and SMC Chapter 2.68, helping the City administer the use of funds from the 2% special excise tax for lodging authorized by RCW 67.28.180. To qualify for voting membership on this committee an applicant must be able to answer “Yes” to *one* of the two questions below and “No” to the other:

***APPLICANTS FOR COUNCIL SALARY COMMISSION (2 YEAR TERMS)**

The Council Salary Commission is governed by SMC 2.48 and is authorized to periodically review and set the compensation schedules for the City's elected officials. Salary Commission members are appointed by majority vote of the City Council. Applicants must answer the following questions:
